COMES NOW Applicant and shows the Honorable Commission as follows:

1. <u>Parties</u>: Applicant herein is Linn Operating, Inc., J P Morgan Chase Tower, 600 Travis, Ste 5100, Houston, TX 77002 (281) 840-4162. For inquiries please contact Dan Furbee - (281) 840-4162. The attorney for the Applicant is Michael D. Stack, 943 East Britton Road, Oklahoma City, Oklahoma 73114, Telephone: (405) 286-1717; Fax (405) 286-2122. The names and addresses of each person or governmental entity, other than the Applicant, currently having the right or claiming to have the right to participate in production from the below common sources of supply are set forth on Exhibit "A" attached hereto and made a part hereof.

2. <u>Facts</u>:

2.1 Applicant has the present right to drill in Section 21, Township 22 North, Range 16 West, Major County, Oklahoma. Said captioned unit was designated as a 640 acre drilling and spacing unit for production as follows: Order No. 36604 later amended by Order No. 48601 for the Mussellem Sand; Order No. 38137 later amended by Order No. 48601 for the Chester Lime; Order No. 59756 for the Oswego Lime; Order No. 131122 for the Red Fork (Cherokee); and Order No. 301507 for the Douglas Group, Hunton, Mississippi Lime, Shawnee Group, Waubunsee Group and Permian common sources of supply.

2.2 There are presently four wells completed in the above common sources of supply located in the captioned unit.

2.3 Since the date of entry of the drilling and spacing unit additional or new data has been obtained in connection with the separate common source of supply sufficient to show a substantial change in conditions or change in knowledge of conditions existing in said unit. It appears that the existing wells will not and cannot effectively and efficiently drain all of the primarily recoverable hydrocarbons in such separate common sources of supply underlying such land. Therefore, the Commission should increase the well density for a well in above common sources of supply underlying Section 21.

2.4 Applicant request the Commission to authorize and permit an additional well by allowing the well in Section 21 to produce hydrocarbons from the Mussellem Sand, Chester Lime, Oswego Lime, Red Fork (Cherokee), Douglas Group, Hunton, Mississippi Lime, Shawnee Group Waubunsee Group and Permian as an exception to Order No. 36604, Order No. 38177, Order No. 48601, Order No. 59756, Order No. 131122 and Order No. 301507 and the Commission should establish a proper allowable for super well and such unit.
