AMENDED APPLICATION

1. **PARTIES:**

Applicant is **TPR Mid-Continent, LLC**. Its address is 9020 North Capital of Texas Highway, Building 1, Suite 170, Austin, Texas 78759, Telephone **(512) 814-0345**. It is the owner of oil and gas leasehold interests within Section 28, Township 10 North, Range 7 West, Grady County, Oklahoma. The parties being named as respondents to this application are set out on the Exhibit "A" attached hereto and made a part hereof.

2. **ALLEGATION OF FACTS:**

(A) In the opinion of the Applicant said Section 28 is underlain by the Mississippian, Woodford, and Hunton common sources of supply. The Applicant recommends the creation of 640-acre horizontal drilling and spacing units for those common sources of supply underlying said Section 28. There is no existing spacing for the Woodford common source of supply underlying said Section 28. There is no existing production from the Mississippian, Woodford, and Hunton common sources of supply in said Section 28.

(B) The Corporation Commission has heretofore, by Order No. 107705, established 640-acre drilling and spacing units for the Mississippian and Hunton common sources of supply underlying Section 28, Township 10 North, Range 7 West, Grady County, Oklahoma.

(C) Subsequent to the entry of the Order above, there has occurred a substantial change in condition and a substantial change in knowledge of condition from that which was thought to exist on the date that Order was entered, which evidences that the described common sources of supply could be more appropriately spaced on the basis of 640-acre horizontal drilling and spacing units. Therefore, Applicant recommends the amendment of such Order to vacate the 640-acre drilling and spacing units established for the Mississippian and Hunton common sources of supply underlying said Section 28.



(D) Attached to this application and marked as Exhibit "B" is a plat showing the drilling and spacing units requested, together with any drilling and spacing units abutting or overlapping the lands within said Section 28.

3. **LEGAL AUTHORITY:**

The relief requested is authorized by Title 52, Okla.Stat. Ann., §87.1.

4. **RELIEF SOUGHT:**

The relief requested is:

(A) The amendment of Order No. 107705, the terms of which established 640-acre drilling and spacing units for the Mississippi Lime and Hunton common sources of supply underlying Section 28, Township 10 North, Range 7 West, Grady County, Oklahoma, to vacate those common sources of supply from the purview thereof.

(B) An Order creating 640-acre horizontal drilling and spacing units for the Mississippian, Woodford, and Hunton common sources of supply underlying said Section 28. Said 640-acre units to be formed by the governmental section, with the permitted well location to be at any point in said unit not closer than 165 feet to the north/south boundaries thereof and not closer than 330 feet to the east/west boundaries thereof for the Woodford common source of supply, and not closer than 660 feet to the boundary thereof for the Mississippian and Hunton common sources of supply.

(C) Applicant may request that said Order be made effective on a date prior to its signing.

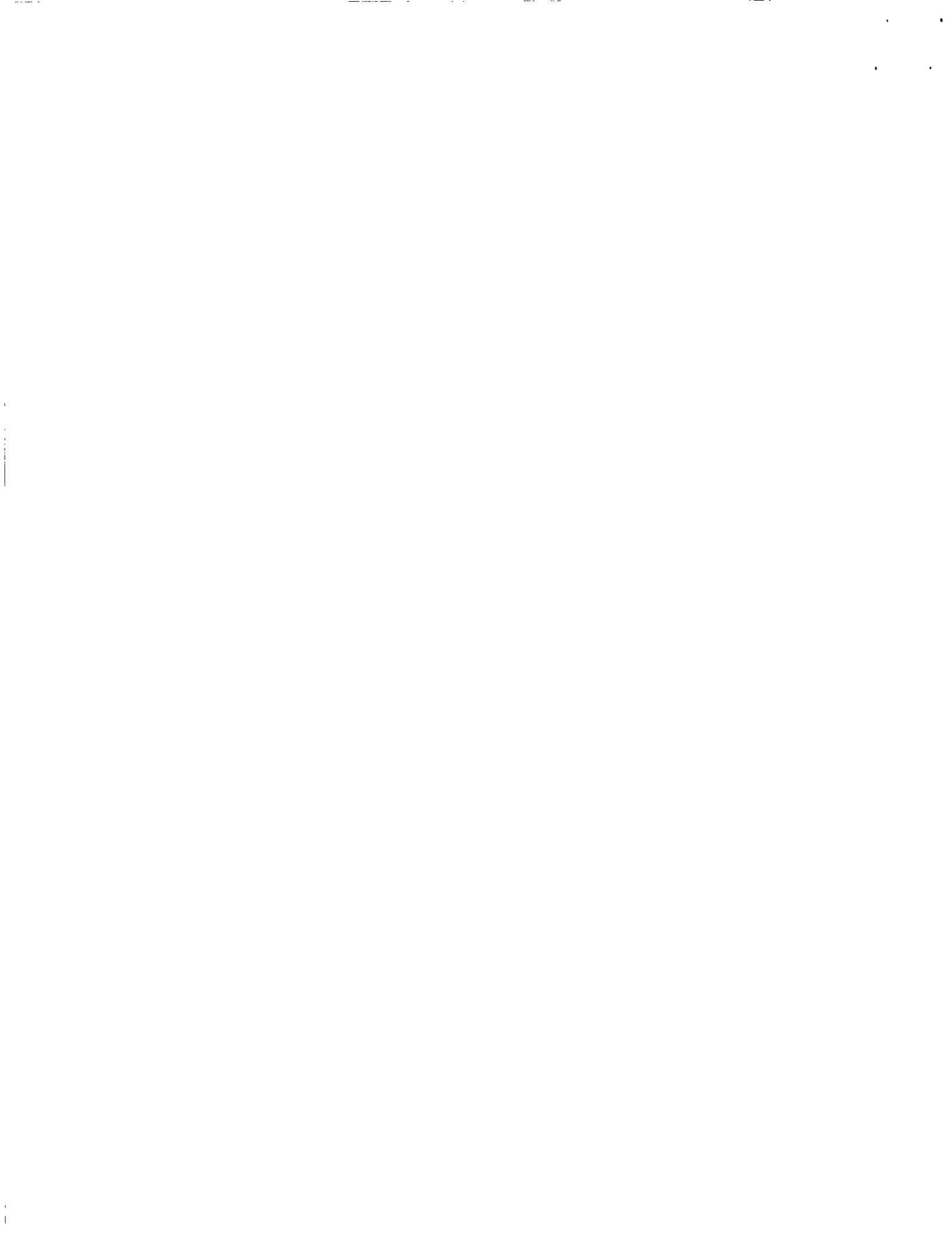
