1. **PARTIES:**

Applicant is Apache Corporation. Its address is Two Warren Place, Suite 1500, 6120 South Yale, Tulsa, Oklahoma 74136-4224. It is the owner of oil and gas leasehold interests within Section 30, Township 12 North, Range 22 West, Beckham County, Oklahoma. There are no parties being named as respondents to this Application.

2. **ALLEGATION OF FACTS:**

(A) The Corporation Commission has heretofore, by Order No. 138431, established a 640-acre drilling and spacing unit for the Hoxbar common source of supply underlying Section 30, Township 12 North, Range 22 West, Beckham County, Oklahoma.

(B) The permitted well location under the Order above is a point not closer than 1,320 feet from the unit boundary.

(C) The Applicant is proposing to drill a well in the Hoxbar common source of supply for the 640-acre drilling and spacing unit consisting of Section 30, Township 12 North, Range 22 West, Beckham County, Oklahoma. The well will be a horizontal well in the Hoxbar common source of supply with surface location and completion interval as follows:

4. **RELIEF SOUGHT:**

The relief requested is for an Order authorizing Apache Corporation, or some other party, to drill, complete and produce a well in the Hoxbar common source of supply for the 640-acre drilling and spacing unit consisting of Section 30, Township 12 North, Range 22 West, Beckham County, Oklahoma. The well will be a horizontal well in the Hoxbar common source of supply with surface location and completion interval as follows:
