COMES NOW the Applicant and alleges and states: COURT CLERK'S OFFICE - TULSA
CORPORATION COMMISSION
OF OKLAHOMA

1. Parties: Applicant is Newfield Exploration Mid-Continent Inc., 100 West 7th St., Suite 1300, Tulsa, Oklahoma 74119, (918) 582-2690, by and through its attorney, William H. Huffman, 400 Beacon Building, 406 S. Boulder Ave., Tulsa, Oklahoma 74103-3800, (918) 599-8000, the owner of the right to drill a well to the common sources of supply named in this Application underlying the captioned property. The name and address of each party being made a respondent to this Application is set forth on Exhibit "A" attached hereto and made a part hereof.

2. Allegation of Facts: That under Order No. 535437, the Corporation Commission spaced the subject tract as a 640-acre drilling and spacing unit for the production of gas from the Woodford common source of supply. This order provides that only one well may be drilled into the common source of supply. The Applicant has drilled the Genevieve 1H-36 well to the Woodford common source of supply. That based upon the well information and production provided by the drilling of this well, it has been determined that such pattern is not adequate when taking into consideration the changed conditions which now prevail as compared to conditions as known when such well pattern was first ordered. That it is now necessary to drill one additional well on said unit in order to effectuate the maximum recovery of hydrocarbons from said common source of supply. That in order to prevent waste and protect the correlative rights of the parties in the reservoir, the Applicant or some other person should be allowed to drill one additional well to the Woodford common source of supply underlying Section 36, Township 6 North, Range 11 East, Hughes County, Oklahoma.

3. Legal Authority: Title 52 O.S. § 87.1.

4. Relief Sought: The Applicant requests that Order No. 535437 be amended by authorizing the drilling of one additional well on the unit comprised of Section 36, Township 6 North, Range 11 East, Hughes County, Oklahoma, to a depth sufficient to test the Woodford common source of supply, possibly providing another person drill said well and possibly providing that this Order be made effective on a date prior to the date of the signing of the Order.

WHEREFORE, Applicant prays that, after notice and hearing as required by law, an Order be issued amending said Order authorizing the drilling of one additional well on the above described unit at the location requested by Applicant.
