COMES NOW the Applicant, Devon Energy Production Company, L.P., and shows the Honorable Corporation Commission the following:

1. PARTIES:

- 1.1 Applicant is: Devon Energy Production Company, L.P.

Applicant is the owner of the right to drill a well to the common sources of supply named below underlying the lands described in the caption hereof.

- 1.2 Respondents are set out on the Exhibit "A" attached hereto and made a part hereof.

2. ALLEGATION OF FACTS:

2.1 That heretofore by Order Nos. 83383, 82505, 83913 and 83919, this Commission designated Section 15-9N-9W, Caddo County, Oklahoma, as a 640-acre drilling and spacing unit for the production of hydrocarbons from the Tonkawa, Medrano, Cottage Grove, Hoxbar, Deese, Morrow and Springer common sources of supply, and designated the unit well to be drilled no closer than 1,320 feet from the unit boundary.

2.2 Applicant proposes to drill a well for the purpose of testing the Tonkawa, Medrano, Cottage Grove, Hoxbar, Deese, Morrow and Springer common sources of supply which well would be located as follows: no closer than 660 feet from the south line and no closer than 660 feet from the west line of Section 15-9N-9W, Caddo County, Oklahoma.

2.3 The location of Applicant's proposed well will not comply with the orders of the Commission and an exception must be granted so that Applicant may drill a well at the proposed location.

2.4 In order to prevent waste and to protect correlative rights, Applicant desires an exception to the prescribed unit well location for the common sources of supply named above so that said well may be drilled by Applicant or some other party at a location no closer than 660 feet from the south line and no closer than 660 feet from the west line of Section 15-9N-9W, Caddo County, Oklahoma.

3. LEGAL AUTHORITY: Title 52 O.S. 1971, §87.1.

4. RELIEF SOUGHT: The Commission should issue an order granting Applicant or some other party designated at the time of hearing, an exception to the well location prescribed for the above-named common sources of supply so that said well may be located at the proposed

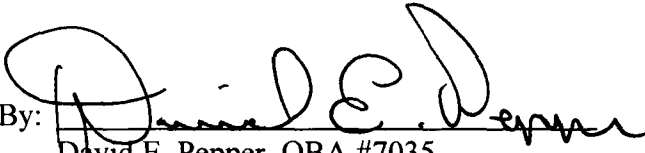
