1. Parties.

1.2 Applicant is the owner of the right to drill a well into and to produce hydrocarbons from the Wapanucka, Union Valley, Caney, Mayes, Woodford, Hunton, Sylvan and Viola separate common sources of supply underlying Section 30, Township 6 North, Range 15 East of the IM, Pittsburg County, Oklahoma.

2.2 The development or trend of development in the area indicates that said Section 30 is wholly or substantially underlain by the Wapanucka, Union Valley, Caney, Mayes, Woodford, Hunton, Sylvan and Viola formations, as part of the Wapanucka, Union Valley, Caney, Mayes, Woodford, Hunton, Sylvan and Viola separate common sources of supply of gas, respectively, as established by the orders set out in paragraph 2.1, above. In the interest of securing the greatest ultimate recovery of oil and gas, preventing the various types of waste and protecting correlative rights, the orders set out in paragraph 2.1, above, as to the Wapanucka, Union Valley, Caney, Mayes, Woodford, Hunton, Sylvan and Viola separate common sources of supply, should be amended to enlarge and extend the boundaries of such separate common sources of supply so as to cover and include said Section 30, and proper drilling and spacing units should be formed for such separate common sources of supply in such section, which units should be formed as 640-acre drilling and spacing units.

2.3 Attached to this application as Exhibit "B" and made a part hereof is a plat showing the drilling and spacing units requested, together with any drilling and spacing units abutting or overlapping the area herein sought to be spaced.

3. Legal Authority. The relief sought by this application is authorized by 52 O.S. §87.1.

4. Relief Sought. Applicant requests the Corporation Commission of Oklahoma to enter an order, to be effective as of the date of the execution thereof or as of a date prior thereto, as follows:

(i) Amending the orders set forth in paragraph 2.1, above, to enlarge and extend the boundaries of the Wapanucka, Union Valley, Caney, Mayes, Woodford, Hunton, Sylvan and Viola separate common sources of supply of gas so as to cover and include Section 30, Township 6 North, Range 15 East of the IM, Pittsburg County, Oklahoma, and to form proper drilling and spacing units in such section for such separate common sources of supply, which units Applicant requests be formed as 640-acre drilling and spacing units; and

(ii) Granting such other and further relief as may be proper based upon the evidence presented at the hearing herein.
