APPLICATION

COMES NOW Applicant and shows the Honorable Corporation Commission as follows:

1. Parties: The Applicant is Jones Energy, LLC; Nosley SCOOP, LLC; and Nosley Acquisition, LLC, 807 Las Cimas Parkway, Suite 350, Austin, TX 78746. The name and address of each party being made a respondent to this Application is as shown on Exhibit "A" attached hereto and made a part hereof. If any named natural person is deceased, then the known or unknown heirs, executors, administrators, trustees, devisees and assigns immediate and remote, of such decedent are made respondents to this Application. If any named respondent is a corporation which does not continue to have legal existence, then the known or unknown successors, trustees or assigns, if any, of such entity are made respondents to this Application.

2. Allegation of Facts:

a. Applicant has conducted a diligent and meaningful search of the local county assessor's records, county treasurer's records, county deed records regarding the property involved for return addresses on recorded instruments, county probate records and city and county telephone directories and other sources of such information to locate the whereabouts and mailing address of each respondent, or the identify, whereabouts and mailing address of respondent's heirs, executors, administrators, trustees, successors, devisees or assigns, if any.

b. Applicant alleges that the lands in the caption hereof overlie the actual or prospective common sources of supply named below; that Applicant owns oil and gas interests in the area covered by this Application which entitle Applicant to drill for and produce oil and gas from the lands covered by the Application; that the protection of correlative rights and the prevention of waste require that proper drilling and spacing units and well locations be established therefore as horizontal well units, with anticipated hydrocarbon classification and depths as follows:

c. That a single 640-acre horizontal well drilling and spacing unit should be established for the Mississippian, Woodford, and Hunton common sources of supply underlying Section 28, Township 10 North, Range 7 West, Grady County, Oklahoma, as set out below. There are no wells producing from the common sources of supply sought to be spaced herein.

d. By Order No. 107705, this Commission established a 640-acre drilling and spacing unit for the Chester, Mississippi Lime, and Hunton common sources of supply underlying Section 28, Township 10 North, Range 7 West, Grady County, Oklahoma. Since the date of said Order, there has been a substantial change in conditions or a substantial change in the knowledge of conditions in the area which necessitates vacating Order No. 107705 insofar as it pertains to the Chester, Mississippi Lime, and Hunton common sources of supply underlying Section 28, Township 10 North, Range 7 West, Grady County, Oklahoma.

e. By Order No. 664890, this Commission established a 640-acre horizontal drilling and spacing unit for the Mississippian, Woodford, and Hunton common sources of supply underlying Section 22, Township 10 North, Range 7 West, Grady County, Oklahoma, and Order No. 664890 should be extended to include within its purview the Mississippian, Woodford, and Hunton common sources of supply underlying Section 28, Township 10 North, Range 7 West, Grady County, Oklahoma.

f. That the permitted well in the drilling and spacing unit requested herein is necessary to effectively and efficiently drain the portion of the common sources of supply (reservoir) covered by such drilling and spacing unit, there being no existing well within the drilling and spacing unit which can effectively and efficiently drain the portion of the common sources of supply (reservoir) covered by such drilling and spacing unit.

3. Legal Authority: Title 52, Section 87.1, O.S.

4. Relief Sought: Applicant requests that the Commission enter an Order granting the following relief:

- (a) vacating Order No. 107705 insofar as it pertains to the Chester, Mississippi Lime, and Hunton common sources of supply underlying Section 28, Township 10 North, Range 7 West, Grady County, Oklahoma; and,

- (b) extending Order No. 664890 to include within its purview the Mississippian, Woodford, and Hunton common sources of supply underlying Section 28, Township 10 North, Range 7 West, Grady County, Oklahoma.


with the unit well for said 640-acre horizontal unit to be located from its point of entry and along any point of its lateral, not less than 660 feet from said unit boundary for the Mississippian and Hunton common sources of supply, and not less than 165 feet from the north and south unit boundary and not less than 330 feet from the east and west unit boundary for the Woodford common source of supply.

5. Relationship to Non-Horizontal Units: Pursuant to Oklahoma Corporation Commission Rule 165:10-3-28(e)(4) and 165:5-7-6(g) the Order to enter in this cause shall exist concurrently with any non-horizontal drilling and spacing units which are not vacated herein, and which are contained within the boundaries of the horizontal unit created hereby. Further, each concurrently existing unit may be separately developed in that a well may be drilled into, completed in, and produce hydrocarbons from the same common source of supply in each such concurrently existing unit, with production from such well to be governed by and allocated pursuant to the applicable unit.

6. Applicant further requests that the Order to be entered in this cause possibly be made effective as of the day of the hearing, or on some other date prior to the date of signing.

WHEREFORE, Applicant prays that, after notice and hearing as required by law, the drilling and spacing unit as requested by Applicant, with appropriate well locations and exceptions thereto, be ordered.
