



(A) The amendment of Order No. 107705, the terms of which established 640-acre drilling and spacing units for the Mississippi Lime and Hunton common sources of supply underlying Section 28, Township 10 North, Range 7 West, Grady County, Oklahoma, to vacate those common sources of supply from the purview thereof.

(B) An Order creating 640-acre horizontal drilling and spacing units for the Mississippian, Woodford, and Hunton common sources of supply underlying said Section 28. Said 640-acre units to be formed by the governmental section, with the permitted well location to be at any point in said unit not closer than 165 feet to the north/south boundaries thereof and not closer than 330 feet to the east/west boundaries thereof for the Woodford common source of supply, and not closer than 660 feet to the boundary thereof for the Mississippian and Hunton common sources of supply.
