2. Allegation of Facts: That heretofore, by Order No. 663022, this Commission established a 640-acre horizontal drilling and spacing unit for the Mississippian (less Chester) common source of supply underlying the lands described in the caption. Applicant does not believe the existing well can adequately and efficiently develop the entire unit, and therefore, Applicant requests authority to drill and produce three (3) additional wells as an exception to the above described Order.

3. Legal Authority: Title 52 O.S., Section 87.1.


