2. Facts: Applicant, an owner of the right to drill, has drilled or proposes to drill a well to develop each common source of supply shown in Paragraph 4 herein and each drilling and spacing unit therefore as a unit. Respondents and Applicant have not agreed to pool their interests so as to develop each common source of supply and each drilling and spacing unit therefore as a unit. Due diligence has been exercised to locate each Respondent. A bona fide effort was made to reach agreement with each such Respondent to develop each common source of supply and each drilling and spacing unit therefore as a unit.

3. Legal Authority: Title 52 O.S., Section 87.1.

4. Special Relief Sought: Applicant requests the Commission (a) issue an Order pooling interests and adjudicating the rights and equities of oil and gas owners in the Cleveland, Prue, Skinner, Red Fork and Bartlesville common sources of supply underlying the SW/4 SW/4 of Section 25, Township 20 North, Range 8 East, Pawnee County, Oklahoma, a 40-acre drilling and spacing unit for the said common sources

of supply; (b) reserve the right to request the Order in this Cause be made effective on a date prior to the date of issuance; (c) name Applicant as Operator of the unit well, of each such common source of supply, and of each drilling and spacing unit therefore as a unit; (d) pool interests and adjudicate rights and equities in the unit well, in each such common source of supply, and in each such drilling and spacing unit therefore on a drilling and spacing unit basis; and (e) request the Operator be given an option to request in excess of 180 days in which to commence operations for the drilling of the initial well.

WHEREFORE, Applicant prays that, after notice and hearing as required, the relief sought be granted.
