Applicant is the owner of the right to drill a horizontal well to the common sources of supply named below underlying the lands described in the caption hereof.

1.2 Respondents are set out on the Exhibit "A" attached hereto and made a part hereof.

2. ALLEGATION OF FACTS:

2.1 That heretofore by Order No. 623225, this Commission granted the Applicant an Interim Order for the establishment of a Multiunit Horizontal Well in the subject lands. The Interim Order found that the well was to be drilled beginning in Section 17 with the first perforation no closer than 150 feet from the south line and no closer than 330 feet from the west line and the last perforation no closer than 0 feet from the north line and no closer than 330 feet from the west line and in Section 8 with the first perforation no closer than 0 feet from the south line and no closer than 330 feet from the west line and the last perforation no closer than 150 feet from the north line and no closer than 330 feet from the west line.

2.2 Subsequent to the entry of Order No. 623225, the Applicant has been required to change the location of the Multiunit Horizontal Well. The well will now be drilled as follows:

Section 17-1N-5W:

first perforation: not closer than 150 feet from the south line and not closer than 330 feet from the east line of said Section 17-1N-5W, Stephens County, Oklahoma,

last perforation: not closer than 0 feet from the north line and not closer than 330 feet from the east line of said Section 17-1N-5W, Stephens County, Oklahoma,

Section 8-1N-5W:

first perforation: not closer than 0 feet from the south line and not closer than 330 feet from the east line of said Section 8-1N-5W, Stephens County, Oklahoma

last perforation: not closer than 150 feet from the north line and not closer than 330 feet from the east line of said Section 8-1N-5W, Stephens County, Oklahoma

The entire length of the lateral will be cemented such that the perforations will be isolated from the beginning and end point of the lateral in order to protect the correlative rights of the offset units.

2.3 Applicant requests that Order No. 623225 be modified to provide for the actual proposed location.

4. **RELIEF SOUGHT:** Applicant requests that Order No. 623225 be modified to provide for the proposed location of the Multiunit Horizontal Well as set forth above.


