FINAL ORDER

BY THE COMMISSION:

The Oklahoma Corporation Commission ("Commission") being regularly in session and the undersigned Commissioners being present and participating, there comes on for consideration and action the Report and Recommendations of the Administrative Law Judge ("ALJ") filed May 5, 2008.

On May 15, 2008, the Oklahoma Sustainability Network, Sierra Club, and ClimateMaster, Inc., filed exceptions to the Administrative Law Judge Report. Responses to the exceptions were filed May 20, 2008, by Public Service of Oklahoma ("PSO"), the Attorney General of the State of

Oklahoma ("AG"), Quality of Service Coalition ("QOSC"), CenterPoint Energy Resources Corp., d/b/a CenterPoint Energy Oklahoma Gas ("CenterPoint"), the Staff of the Public Utility Division of the Oklahoma Corporation Commission ("Staff"), Oklahoma Natural Gas Company, a Division of ONEOK, Inc. ("ONG"), and Wal-Mart Stores East, LP ("Wal-Mart"). For a procedural history of this cause prior to May 5, 2008, see the Report and Recommendations of the ALJ.

A hearing was held on the exceptions on June 3, 2008.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

The Commission finds that it is vested with jurisdiction in this matter pursuant to Art. IX § 18, the Oklahoma Constitution, 17 O.S. §§ 151 et seq. and Order No. 545168 issued in Cause No. PUD 200600285.

The Commission further finds that notice was given as required by law and Commission rules and in accordance with the Commission Order.

The Commission further finds that the Report and Recommendations of the Administrative Law Judge shall be affirmed.

The Commission further finds that the Commission is not precluded by this Order from further action relating to demand programs.

The Commission further finds that the Findings of Fact and Conclusions of Law and recommendations contained within the Report and Recommendations of the Administrative Law Judge are hereby adopted as the findings of this Commission.

ORDER

IT IS THEREFORE THE ORDER OF THE CORPORATION COMMISSION OF THE STATE OF OKLAHOMA that the Report and Recommendations of the Administrative Law Judge filed May 5, 2008, are hereby affirmed.
