**ORDER GRANTING EMERGENCY  
MOTION FOR EXTENSION OF TIME**

On this 18th day of January, 2013, there came on for hearing before Curtis M. Johnson, Administrative Law Judge of the Corporation Commission of the State of Oklahoma, the Application for Emergency Order filed by MUSTANG FUEL CORPORATION in the above-styled and numbered cause.

David E. Pepper, Attorney, appeared for the Movant, MUSTANG FUEL CORPORATION.

The Administrative Law Judge heard the cause and filed a report recommending that the Application for Emergency Order be granted, which report and recommendations are hereby adopted, and the Commission therefore finds and orders as follows:

**FINDINGS**

1. That the Movant has filed its Motion requesting an extension of Order No. 593349 for an additional period of three hundred sixty five (365) days. Order No. 593349 shall expire on January 25, 2013. Lack of a rig capable of drilling this well has prevented commencement.
2. Applicant's Order will expire prior to the hearing on the merits if emergency relief is not granted.
3. Movant has recently acquired all the interest of the Applicant in this unit, but because of the recent nature of the acquisition, they are unable to have a rig available to commence operations. Movant is requesting an emergency extension of Pooling Order No. 593349 until March 4, 2013. The hearing on the Motion is February 4, 2013.
4. The Movant will suffer a financial loss which could approach \$20,000 without the extension.
5. That in order to prevent waste and to protect correlative rights, Movant desires a special order authorizing the extension of said Order as set forth above during the pendency of the action hereof. This Order shall be effective as of January 18, 2013.
