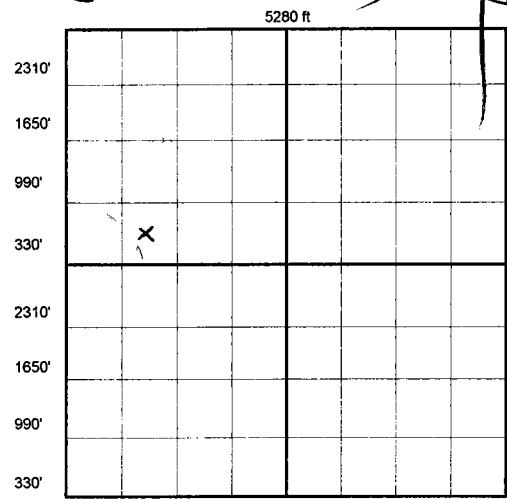

The undersigned, for the purpose of filing these Articles of Merger pursuant to 18 O.S. § 2054, does hereby execute the following Articles of Merger:

1. The name and jurisdiction of formation or organization of the domestic entities which are to merge are: Calumet Oil Company, an Oklahoma corporation ("Calumet") and Chaparral Energy, L.L.C., an Oklahoma limited liability company ("Chaparral").
2. An Agreement and Plan of Merger (the "Merger Agreement") has been approved and executed by the sole stockholder of common stock and the Board of Directors of Calumet and the sole manager and the sole member of Chaparral.
3. Chaparral will be the surviving limited liability company.
4. As a result of the merger, the Articles of Organization of Chaparral shall stand as currently filed with the Oklahoma Secretary of State.
5. The effective date of the merger is to be October 1, 2007.
6. The Merger Agreement is on file at the principal place of business of Chaparral at 701 Cedar Lake Blvd., Oklahoma City, Oklahoma 73114.
7. A copy of the Merger Agreement shall be furnished by Chaparral upon request and without cost, to any member who holds an interest in either Chaparral or Calumet.
