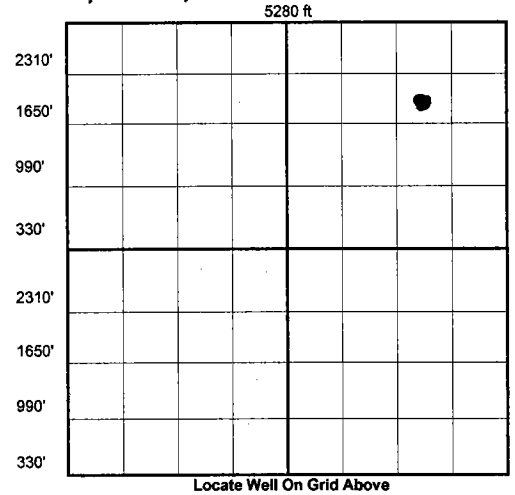

ORDER NAMING AND DIRECTING RECEIVER

On the 13th day of July, 2012, the above styled cause came on for hearing upon the Defendant's motion to name the Receiver and to issue directions to the Receiver. The Plaintiffs appeared and were represented by counsel. The Defendant appeared and was represented by counsel.

This Court has previously ordered that a receivership is necessary and the Receiver is to be named by the Court after receiving suggestions from the parties. The Court has heard and overruled the Plaintiffs' motion to reconsider the appointment of a Receiver.

The Court finds that the Receiver for the Reed family businesses known as Reed Power Tongs, Inc., Reed Land and Cattle, LLC, K & H Well Service, Inc., and JKJ Oil & Gas, LLC, shall be C. David Rhoades. The Receiver shall post a bond in the amount of \$1,000,000 (One Million Dollars) with one or more sufficient sureties to be approved by the Court. Said bond shall be in the usual, sufficient form for receivers in cases such as this and shall be in favor of The State of Oklahoma, District Court of Seminole County. The premium for said bond shall be paid from the receivership assets.

THE COURT DIRECTS THE RECEIVER AS FOLLOWS:

1. The Receiver shall <sup>*review & analyze*</sup> ~~take control~~ of the assets and daily operations of the businesses known as the Reed family businesses as listed above, and will immediately be

responsible for <sup>protecting</sup> and marshaling the tangible and intangible assets of the businesses wheresoever situated, real and personal property, including, but not limited to, leasehold rights, equipment, stock on hand, livestock and racehorses.

2. The Receiver shall cause the businesses to be operated <sup>by the persons law operating</sup> so as to preserve the <sup>said business</sup> assets and reasonably enhance the value of the assets.

3. The Receiver shall, within 60 days, prepare and submit to the Court and parties, an Inventory of all assets and liabilities of the businesses, indicating an estimate of the fair market value of each asset worth in excess of \$10,000 and a total estimate of value of the assets.

4. The Receiver shall investigate and determine the likely ownership interest of any persons or entities in and to the assets of the businesses, and shall report same to the Court and parties. The Receiver shall investigate and prepare a report of all transactions of the businesses for the previous one year from the date of his appointment to assist the Court in determining what actions have been taken by Plaintiffs since Defendant's exclusion from the businesses.

5. The Receiver is authorized to obtain or maintain all necessary licenses, permits, or applications on behalf of the businesses, <sup>as may be needed and not already obtained</sup> and may issue subpoenas to obtain documents and conduct discovery as a party to this action.

6. In the event that any of the parties to this action have any assets of the businesses in their possession, or have transferred any assets that were property of the businesses <sup>within the past 265 days</sup>, the parties shall identify those assets and <sup>turn them over</sup> to the Receiver <sup>at the Receiver's discretion</sup>. The Receiver is authorized to file civil actions to recover assets of the businesses <sup>(except in the ordinary course of business)</sup>.

7. The parties herein are ordered and directed to cooperate fully with the Receiver and assist the Receiver in the performance of his duties. This assistance shall include turning over information that the Receiver deems necessary, providing codes or passwords required to access computer files or bank information, and advising all persons who owe money to the businesses that the debts should be paid to the Receiver. <sup>See business in the primary Court of business</sup>


8. The Receiver may ~~sell or dispose of assets, subject to accounting, that have a value less than \$10,000 and may petition the Court for permission to sell or transfer other~~ <sup>assets,</sup> <sup>and in his opinion should be sold or transferred.</sup>

9. The Receiver shall report to the Court on a quarterly basis. The Receiver shall petition the court for payment of fees and costs. <sup>and may seek assistance from the Court on any matter at any time, and on notice to all parties at the of Receiver</sup>

10. The Receiver shall have the rights and obligations imposed by Oklahoma law. The Receiver shall be a party to this action for purposes of all notices and appearances.
