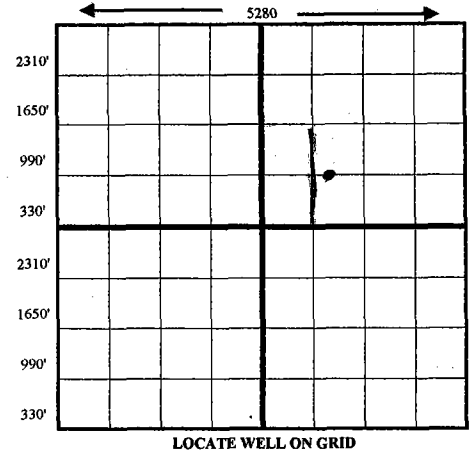

LOCATE WELL ON GRID

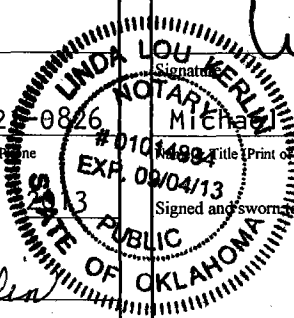
