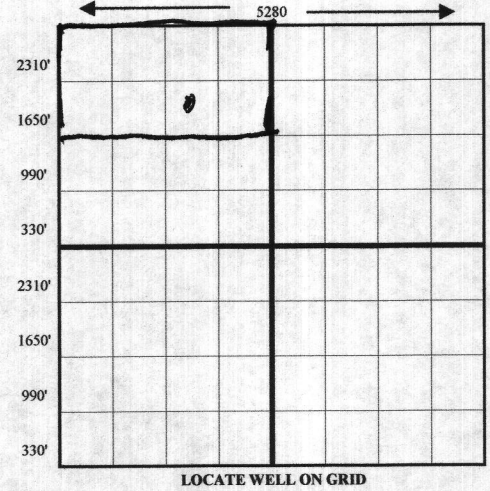

- F. Attach M.I.T. less than 1 year old. (<30 days for commercial)




